1. What scope does Law Outline course cover?

- Thirdly, since law outline course is not merely a theoretical subject, students should try to think of simulated scenarios related to law and apply the knowledge to solve them. This will sharpen students' skill to smoothly handle issues related to legal practices in their work after graduating as well as daily life.
