DR. NGUYỄN THÁI HỢP (Ed.). **Justice and peace in the East Sea**. H.: Writers association publishing house, 2014, 359 pages, Vv 12540.

In order to raise awareness in history society, especially of young people, yo participate in research to affirm the sovereignty of Vietnam over Paracels - Spratlys while find the most feasible and effective solutions to protect the independence, sovereignty and erritorial integrity of Vietnam, the book is a collection of research articles by many scholars such as Nguyễn Đình Đầu, Hồ Sĩ Quý, Đinh Kim Phúc, Phạm Hoàng Quân, Đinh Hoàng Thắng, Hoàng Việt, Tạ Văn Tài, Lê Trung Tĩnh, Lê Vĩnh Trương... discussing 3 areas: geography, history, legal and international relationships.

The book consists of 8 key issues:

Part I: History of Southward journey and the East Sea.

Part II: Process of occupying and exercising sovereignty of Vietnam over Paracels and Spratlys - Factual, uninterrupted, peaceful and transparent.

Part III: Objecting opinions of some Chinese scholars on the East Sea.

INSTITUTE OF PUBLIC POLICY AND LAW, INSTITUTE OF STATE AND LAW. Some theoretical and practical issues on direct democracy, grassroots democracy in the world and in Vietnam. H.: National university, 2014, 328 pages, Vv 12474.

Direct democracy and grassroots democracy are two forms of democracy which have been in Vietnam for long time and recently been promoted actively by the Communist Party and the State of Vietnam. The forms of democracy have gradually been strengthened and improved. The progress in implementation of direct democracy and representative democracy has been able to penetrate extensively into all classes of people and regions of the country, creating new contagious models. However, in relations to direct democracy, grassroots democary still has many unclarified theoretical and practical aspects.

The book is a collection of speeches conference held by Institute of Public Policy and Law in collaboration with Institute of State and Law in Hanoi in March 2014. Contents of the book contribute to unravel the theoretical and practical aspects of direct democracy, grassroots democracy; implementation models of direct democracy, grassroots democracy in the world and in Vietnam. In particular, the first direct democracy of humankind - Athenian democracy has been discussed by the author under many different perspectives. NGUYĒN VĂN KHANG. Language policy and legislaive in Vietnam. H.: Social sciences publishing house, 2014, 564 pages, Vv 12568.

The book is written on the basis of 2 Ministry-level projects chaired by the author in the period 2009-2012 and materials collected by colleagues. The book consists of 2 parts.

Part 1 present the language policy of the Party and the State of Vietnam with 6 chapters. Chapter 1 is theoretical issues of language policy, presenting concepts, the basis of establishing language policy, the relationship between language policy and language Chapter legislative... presents 2 language policies of other countries in the world such as language policy model (covert language policy, overt policy...); the trend language globalization and integration... Chapte 3, 4, 5 presents language policy of the Communist Party and the State of Vietnam by historical development (periods from establishment of the Party to 1954, from 1954 to 1975 and from 1975 to now). Chapter 6 presents social - linguistic factors affecting situation of language in Vietnam. On that basis, it proposes a number of provisions on language policy of Vietnam in new period.

Party 2 presents language legislative in Vietnam through 5 chapters, with focus on clarifying: the general issues of language legislative and Languages Act (chapter 7); experience of developing Languages Act of other countries in the world: case studies (chapter 8); basis for developing Languages Act in Vietnam (chapter 9); direction for developing Languages Act in Vietnam (chapter 10); Features of Vietnamese language in the legal text (chapter 11).

Democracy, dictatorship and development as well as their relationships are a fundamental hot topics on both academic and political levels. Perspectives on each issue and the combination of these issues depend first and foremost on the political perspectives, the volume information, knowledge and the rules of historical circumstances. The book talks the mentioned issues as reality of the recent past and of those contemporary years, the book itself catches the attention of experts and readers in general ... Through processing of a huge material volume, the author analyzes. collates, reviewes connotation and relationships amongst these issues ... to go to conclusions which worth to refer to and reflect further. The book consists of 3 chapters.

Chapter 1 - Democracy, dictatorship and development: Some theoretical issues, introducing the concepts of democracy, the democracy, dictatorial indexes, main dictatorial forms...

Chapter 2 - Democracy, dictatorship and development in some countries and regions, generalizing about democracy, dictatorship and development in the USSR in Stalin era, South Korea, Taiwan, some Southeast Asian countries and Latin America.

Chapter 3 - Democracy, dictatorship and development: Some practical issues, delving into issues which have been emerging from the reality of democracy and dictatorship in the mentioned countries; on that basis, providing some suggestions for the development of democracy in the countries following.

ASSOC. PROF., DR. NGUYÉN NGỌC HÒA (Ed.). The changes of traditional social values of ethnic minorities in the Central Highlands today. H.: National political publishing house, 2014, 183 pages, Vb 51703.

The history of Central Highlands has formed a fairly massive system of traditional social values. However, under the influence of multiple factors, the traditional social values of the Central Highlands have been profoundly changed. In addition, there is the emergence of new values and tendency to acquire new values in communities of ethnic minorities, making an different overall in the structure of the common tradition.

The book consists of 3 chapters.

Chapter 1 generalizes traditional social values, clarifies the role of traditional social values in social life while refers to changing tendency and development of traditional social values during exchanges and integration.

Chapter 2 analyzes the change of traditional social values of ethnic minorities in the Central Highlands.

Chapter 3 forecasts tendency of mobilization and change of traditional social values of ethnic minorities in the Central Highlands, offering fundamental viewpoint for orientation and specific solutions to inherit and promote the traditional social values of ethnic minorities here.

In addition to collect evidence in the past, from atlas, the bibliography pages of different genres in both domestic and abroad, along with the articles of historian researchers in the country, the book also brings together all the voices of international friends who are scholars respecting the history, right and responsible for the peace and development of the The East Sea as well as for international law.

End of the book is the appendix with the article "Following the proof of sovereignty over the Paracels -Spratlys" (Trần Đức Anh Sơn).

ĐINH TUẨN MINH, PHẠM THẾ ANH (Ed.). **Report on Developing Vietnam's market economy in 2014**. H.: Intellectual publishing house, 2015, 552 pages, Vv 12650.

Report on Developing Vietnam's market economy in 2014 is done by the expert groups of the Central Institute of Economic Management (CIEM), Vietnam Institute of Economics (VIE). Vietnam Chamber of Commerce and Industry (VCCI) and the Vietnam Centre for Economic and Policy Research (University **Economics** Vietnam National University (VEPR)). The report covers and evaluates process of transition to market economy in Vietnam in the past 30 years.

The report consists of 10 chapters.

Chapter 1 identifies the characteristics of the market economy, gives the criteria to assess the level of market development in the economies, from which reassesses the development of market economy in Vietnam in relations with other countries in the region.

Chapter 2 analyzes the factors of economic - legal system of Vietnam to provide comprehensive picture of development progress of this system towards market-friendly; assesses the strengths and weaknesses; then proposes the issues to be adjusted to make Vietnam's legal system to suit the development of market economy.

Chapter 3 analyzes, assesses the effectiveness of Vietnamese governance apparatus towards supporting market development.

Chapter 4 analyzes and assesses Vietnamese market-oriented fiscal and monetary system towards the market. Chapter 5 examines the formation and development of Vietnamese enterprise systems towards market in the process of economic reform.

Chapters 6, 7, 8 indicate the evaluation criteria for development and liberalization of Vietnamese labor, capital and land markets.

Chapter 9 analyzes and assesses the development of Vietnamese international trade system towards liberalization.

Chapter 10 gives the trend of policy for Vietnamese market economy development.
